

**OFFICIAL SUMMARY PROCEEDINGS OF THE BOARD OF
COUNTY COMMISSIONERS, TETON COUNTY, WYOMING**

The Teton County Board of Commissioners met in regular meeting on **March 25, 2022** in the Commissioners Chambers located at 200 S. Willow in Jackson. The meeting was called to order at 9:04 a.m.

Commission present: Natalia Macker, Chairwoman, Mark Newcomb and Greg Epstein were present. Luther Propst, Vice-Chairman, and Mark Barron were absent.

ADOPT AGENDA

A motion was made by Commissioner Epstein and seconded by Commissioner Newcomb to adopt the agenda as presented. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

PUBLIC COMMENT

4. Consideration of BLM Land Transfer Project Phase III Proposal from Western Land Group, Inc

Alyssa Watkins, Board of County Commissioner Administrator, presented to the Board for consideration of approval a proposal for Phase III work from Western Land Group, Inc. (WLG) for the Bureau of Land Management (BLM) Land Transfer Project.

On April 7th, 2020, the Teton County Board of County Commissioners (BCC) signed a contract with Western Land Group, Inc. (WLG) to proceed with Phase I of the BLM Land Transfer Project. The BLM Land Transfer Project involves leveraging consultant services to negotiate the specifics of BLM parcel transfers to Teton County, and to work with partner agencies on behalf of Teton County to help develop, recommend, and/or facilitate a transfer or management agreement with partner agencies for the remaining parcels. The scope of work outlined the entirety of Phase II, captured in six tasks. Much of the Phase II work has been completed and WLG is now prepared to move on to Phase III of the project.

Public comment was given by Jared Baecker.

A motion was made by Commissioner Newcomb and seconded by Commissioner Epstein to approve the BLM Land Transfer Project Phase III Proposal from Western Land Group, Inc. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.
