

**OFFICIAL SUMMARY PROCEEDINGS  
OF THE BOARD OF COUNTY COMMISSIONERS, TETON COUNTY, WYOMING**

The Teton County Board of Commissioners met virtually in regular meeting on **September 7, 2021** in the Commissioners Chambers located at 200 S. Willow in Jackson. The meeting was called to order at 9:00 a.m. and the Pledge of Allegiance was recited.

**ROLL CALL**

County Commission: Natalia Macker, Chairwoman, Luther Propst, Vice-Chairman, Mark Newcomb and Greg Epstein were present via Zoom. Commissioner Barron joined the meeting after roll call.

**MATTERS FROM COMMISSION AND STAFF**

**15. Consideration of Budget Allocation to Provide the Funds to Purchase Two K-9 Vehicles**

Matt Carr, Teton County Sheriff, presented to the Board for consideration of approval a request for budget allocation to patrol vehicles.

The Sheriff's Office is asking the Commission to amend \$80,000.00 back into the Sheriff's Office capital budget. \$150,536.00 was removed during the budgetary process of which a portion was to be used for the purchase of two patrol vehicles and a portion for the build out of the vehicles to be K-9 vehicles.

There was no public comment.

A motion was made by Commissioner Propst and seconded by Commissioner Newcomb to amend \$80,000.00 into the Sheriff's Office capital budget for the purchase of two K-9 specific patrol vehicles. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

**16. Consideration of FY22 Budget Increase Related to Travel and Updating a .5 FTE to a FTE Position**

Anne Sutton, Clerk of District Court, presented to the Board for consideration of approval an FY22 Budget Increase Request for travel/salaries.

The CODC Office received notice on August 17, 2021 that the state had an opening for Teton County to transition to FCE earlier than previously expected (scheduled for the first week of June 2022). They previously had reported the county's migration would be in a later fiscal year. The new system (FCE) needs to be operational before the application of the official e-filing system. E-filing is a priority and long-awaited need for the Wyoming District Courts. Travel expenses are forecast to total \$7,950.

There was no public comment.

A motion was made by Commissioner Barron and seconded by Commissioner Epstein to approve the Clerk of District Court's FY2022 budget increase request for an additional \$7,950 in travel funding. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

**17. Consideration of Notice of Award for Comprehensive Water Quality Master Planning Professional Services**

Heather Overholser, Director of Public works, presented to the Board for consideration of approval a Notice of Award for Comprehensive Water Quality Management Planning professional services.

In cooperation with partnering entities, Protect our Water Jackson Hole (POWJH), Teton Conservation District (TCD) and the Town of Jackson, Teton County endeavors to enter into a process of study and planning to shape the current understanding of existing and potential future human-induced threats to both surface water and groundwater quality and develop strategies for properly managing them. This project requires the support of a consultant team with a wide range of engineering, environmental, technical, public engagement, and administrative services to assist Teton County, Wyoming in bringing to completion the development of a Comprehensive Water Quality Management Plan. The Consultant team will create a 20-year vision and implementation plan that protects surface water and groundwater resources from future degradation and improves water quality where known degradation is occurring.

There was no public comment.

A motion was made by Commissioner Barron and seconded by Commissioner Epstein to approve the Notice of Award to Trihydro Cooperation for Comprehensive Water Quality Management Planning professional services. Chairwoman Macker called for a vote. The vote showed three in favor and the motion carried 3-2 with Commissioners Propst and Newcomb opposed.

**22. Consideration of Approval of Agreement with Helicopter Express for Search and Rescue Helicopter Services**

A motion was made by Commissioner Barron and seconded by Commissioner Newcomb to continue this item to September 20<sup>th</sup>, 2021, BCC meeting. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

**MATTERS FROM PLANNING AND DEVELOPMENT**

- 1. Findings of Fact and Conclusions of Law and Order
  - A. Teton Vista Ranches DEV2016-0002

Keith Gingery, Deputy County Attorney, presented to the Board for consideration of approval findings of fact and conclusions of law for DEV2016-0002.

A motion was made by Commissioner Epstein and seconded by Commissioner Newcomb to approve the Findings of Fact and Conclusions of Law and Order granting approval of DEV2016-0002. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

**MATTERS FROM COMMISSION**

- A. **Mask Order Non-Compliance Hotline Report:** Commissioner Epstein alerted the Board to an article published in the Jackson Hole News and Guide regarding a "hotline" to report noncompliance with the mask order. Keith Gingery, Deputy County Attorney, provided information regarding a Health Department call-line

to remove the burden of calls from Police/Sheriff Dispatch. The Board requested more information from the Health Department and the Sheriff.

- B. Northern South Park Transparency:** The Board discussed the request for maps used by Opticos in the Northern South Park Planning process. Keith Gingery, Deputy County Attorney explained the Landowners and the Contractors are scheduled to meet and investigate potential mistakes. The Board requested an extension of the public comment period.

A motion was made by Commissioner Barron and seconded by Commissioner Epstein to extend the public comment period.

Kristi Malone, Senior Long-Range Planner, answered questions from the Board and addressed concerns regarding public comment.

Commissioner Barron withdrew his motion given the information regarding planned discussions with the contractor for Northern South Park.
