The owners of certain property located in Teton County, Wyoming seek to form an improvement and service district for the purposes of covering (1) the capital, operating and maintenance costs of the Snake River Bridge at Astoria, (2) the capital, operating and maintenance costs of the community water system, and (3) the capital operating and maintenance costs of the community waste water system. The name of the proposed district is "Snake River Sporting Club Improvement and Service District" (SRS ISD).
