This instrument ("First Amendment") is made by not less than seventy five percent (75%) of the owners of the lots within Sage Meadows Subdivision.

WHEREAS, a Declaration Of Covenants, Conditions and Restrictions For Sage Meadows Homeowner's Association (Covenants) was recorded on June 4, 1999 in Book 378 of Photo, pages 250-263 in the Office of the Teton County Clerk in Jackson, Wyoming; and

WHEREAS, Section 1 of Article XI of the Covenants provides that they may be amended by not less than seventy five percent (75%) of the lot owners in Sage Meadows Subdivision; and

WHEREAS, the owners desire to amend the covenants with respect to maintenance of the parking area.

NOW THEREFORE, the lot owners hereby declare that all of the lots within the Sage Meadows Subdivision shall be owned, sold, conveyed, encumbered, leased, used, occupied and developed subject to the following provisions, covenants, conditions and restrictions, all of which are for the purpose of preserving and maintaining the natural character and value of the property. The Covenants and this First Amendment shall run with the property and any lot thereof, and shall be binding on all parties having or acquiring any legal or equitable interest in or to the property, and shall inure to the benefit of all of the owners of the property or any part thereof.

1. Section 2 of Article V of the Original Covenants is hereby deleted in its entirety and replaced with the following, namely;

The assessments levied by the Association shall be used to promote the recreation, health, safety, and welfare of the residents and owners of the properties, for the improvements and maintenance of the Common Area, and for the maintenance and repair of the County approved parking area.
