

SECOND AMENDMENT TO THE TOWN OF JACKSON AND TETON COUNTY AGREEMENT ESTABLISHING THE JACKSON HOLE ENERGY SUSTAINABILITY PROJECT JOINT POWER BOARD

This Second Amendment to the Town of Jackson and Teton County Joint Power Agreement for the Jackson Hole Energy Sustainability Project Joint Power Board is made and entered into to be effective as of the 12th day of April, 2016, by and between the Town of Jackson, Wyoming, a Municipal Corporation of the State of Wyoming, hereinafter referred to as “Town”, and Teton County, Wyoming, a duly organized county of the State of Wyoming, hereinafter referred to as “County.”

WITNESSETH:

WHEREAS, The Town of Jackson and Teton County entered into a Joint Power Agreement establishing the Jackson Hole Energy Sustainability Project Joint Power Board on August 15, 2011; and

WHEREAS, the same agreement established the Jackson Hole Energy Sustainability Project Joint Power Board which stated in Paragraph 4 that the board would be comprised of 9 members, with the Town of Jackson appointing two members that are town councilpersons, a town employee and/or the Mayor and shall also appoint one community member to serve on the board. The Teton County Board of County Commissioners shall appoint two members that are Commissioners and/or a county employee and one community member to serve on the Board. The Town and County then jointly appoint two members that are either employees or board members of Lower Valley Energy, and the town and county shall jointly appoint a community member; and

WHEREAS, a First Amendment was made to the Joint Power Agreement on August 4, 2013 that changed the board composition to be 9 members with 5 of the members being community members and remove the option of placing an employee of the town or county on the board ;

WHEREAS, the Town of Jackson and Teton County have determined that the makeup of the board should be changed to once again allow for the possibility of appointing an employee of the town or county to the board.

NOW THEREFORE, it is hereby resolved by the Town and County in consideration of the foregoing and of the cooperation to be had between the parties and the performance of the promises contained herein, and the parties hereto agree as follows:

In Paragraph 4 the membership of the board shall change to reflect more community members being appointed and thus the new Paragraph 4 is adopted.

4. Board Composition. *The Board shall consist of nine (9) voting members all of whom shall be qualified electors of Wyoming. The Jackson Town Council shall appoint one member that is either a town councilperson, the Mayor, or an employee of the Town of Jackson. The Teton County Board of County Commissioners shall appoint one member that is either a Commissioner or an employee of Teton County. The Town and County shall jointly appoint two members that are either employees or board members of Lower Valley Energy, and the town and county shall jointly appoint five (5) community members. The Board shall elect a Chairman, Vice-Chairman, Secretary and Treasurer for 1 year terms. Vacancies for unexpired terms of appointees shall be filled by their respective appointing entity. No individual member of the board shall be personally liable for any actions or procedure of the board. When actually engaged in the performance of their duties, members of the board shall receive no compensation but may be reimbursed for travel and per diem expenses as provided to state employees and as approved by the board. All members shall serve 3 year terms, staggered. If the Jackson Town Council or Teton County Board of County Commissioners choose to appoint an employee of their respective*

governments, they may still assign either a commissioner or councilperson as a non-voting, ex officio, liaison to the Board.
