2. To vote for a person whose name is not printed on the ballot, WRITE IN THE NAME in the blank space provided for write-ins and DARKEN THE OVAL immediately to the left of the person's name.
3. If you make an error, return your ballot to a precinct official and obtain a new one.
4. Use a black ball point pen only.

	<p style="text-align: center;"><b>Constitutional Amendment A</b></p> <p>Currently, the Wyoming Constitution allows the legislature to authorize the investment of public employee retirement systems funds and permanent state funds in equities, such as stock or shares in private or public companies. Permanent funds of the state include funds designated as permanent funds by the Constitution.
