Background / Description / Alternatives (Pros & Cons):

The project will provide concrete curbing around the perimeter of the playground and renovate and replace the safety surfacing. In addition, the project will provide a paved accessible sidewalk from the parking area to the restroom, playground and picnic shelter. The project was identified and funded with the 2006 SPET project.

BID RESULTS: The bids for the Owen Bircher Playground and Sidewalk Project were opened Wednesday January 20, 2010 at 2:00 P.M., 6 vendors were notified and requests for bids was published, from which 5 bids were received. Bid results were as follows:
