You are **COMMANDED** that you cannot allow any withdrawals of funds credits, deposits, choses in action, property and/or rights to property of the judgment debtor in your possession, up to the amount due, from any accounts which the judgment debtor may have with you, or pay any debt due, or to become due, to the judgment debtor, which is not exempt from garnishment, and, you are to retain possession and control of the same or of any that come into your possession or control within 30 days after this **WRIT** is served upon you, except as directed by this **WRIT**, the **ANSWER TO WRIT OF GARNISHMENT BY BANK, SAVINGS AND LOAN, CREDIT UNION, ETC.** or by order of this Court, **up to the amount due.**

4. **IMPORTANT!** Even if you do NOT have possession of or control over any money, credits, deposits, choses in action property and/or rights to property of the judgment debtor in one or more checking accounts, savings accounts, certificates of deposit, trusts, etc., of the judgment debtor, **you are required to file with this Court your answer to this WRIT.**

**NOTICE OF RIGHT TO HEARING**

You, the above named judgment debtor, are hereby notified that money or other property in the possession of your bank, savings and loan or credit union, has been seized by garnishment. If you believe the money or property seized is exempt from garnishment, you may object to said garnishment and have a hearing before the Court. If you wish to contest the garnishment, you **MUST** file with the court a written objection to the garnishment within ten (10) days, excluding Saturdays, Sundays and legal holidays, from the date this Notice was given to you or from the date your money or other property was garnisheed, which ever is sooner. You may use this form or you can just write up your own objection and file it with the court. The following are some of the exemptions to which you may be entitled.

**1. The money seized consists of social security benefits, veteran’s benefits, black lung benefits, aid to families with dependent children, general assistance payments, federal civil service or state retirement system benefits, worker’s compensation benefits, unemployment compensation benefits or other exemptions as provided by law.**
